The United Nations Sustainable Development Goals (UNSDG) Eco Village Transitional Housing Architectural Design Idea Competition to take place in January – March 2021

Environmental and professional organizations in Hong Kong are to stage a design competition aiming to incorporate sustainable development into a Transitional Housing project that helps alleviate the difficulties of the needy due to the housing shortage.

The Government had increased the target of the provision of Transitional Housing to 15,000 units in the coming 3 years in January 2020,

subsequent to the commitment in the 2019 Policy Address to alleviate the difficulties of those waiting for Public Housing for some time and living in inadequate dwellings. The Government had also identified a site of around 3 hectares at Tsat Sing Kong, Pat Heung, Kam Tin, New Territories for the development of Transitional Housing units. It is planned to provide about 900 units with buildings not more than 4-storey high alongside the provision of communal farming spaces in this site by the end of 2022. With innovative and creative design through this Competition, a livable residential community with harmonization and connectivity with the surrounding environment can be expected.

The SDG Eco Village (SDGEV) Transitional Housing Architectural Design Idea Competition is organized by the Professional Green Building Council (PGBC). The Co-organizers are The Hong Kong Institute of Architects (HKIA) and Hong Kong Construction Association (HKCA). The Competition is also supported by the Hong Kong Council of Social Service (HKCSS), Hong Kong Lutheran Social Service (HKLSS), the Transport and Housing Bureau and the Environment Bureau of the Hong Kong Special Administrative Region.

SDG refers to the 17 United Nations Sustainable Development Goals¹ which represent the aspiration of the people on Earth to address the global problems we face together, including poverty, inequality, climate change, environmental degradation, peace and justice. They are closely relevant to the aforesaid Transitional Housing development. The planning, architecture and design of built environment can manifest these SDG concepts. On top of this, this project emphasizes more the development of neighborhood relationship, the promotion of healthy living and the poverty reduction. It is expected that such objectives can be achieved through the integration of transitional housing and community farm. It is therefore intended to feature this Transitional Housing project with the theme of SDG Eco Village.

Renowned jury members would be invited for the Competition, with jury's adjudication scheduled for April/May 2021. The award-winning and shortlisted projects will be showcased to the public in July 2021.
